Does the limited warranty cover discharged batteries?

This limited warranty does not cover merely discharged batteries. If the battery is still not working correctly, determine if the battery is still within the total Limited Warranty Period. The applicable Limited Warranty Period is calculated from the date of sale to the original purchaser.

How long does a battery last under warranty?

This defines the number of full charge/discharge cycles a battery can perform under warranty. A common figure is 6,000 cycles, which equates to about 16 years if used once per day. However, warranties usually end when either the cycle count or the years are reached -- whichever is sooner.
