Do solar batteries qualify for a tax credit?

Luckily, batteries also qualify for the tax credit, whether or not they're installed with solar panels. Before 2022, a battery storage system had to charge exclusively from solar energy to qualify for the tax credit. Then Congress passed the Inflation Reduction Act, which updated the tax credit to include batteries not charged from solar power.

Are solar batteries tax deductible?

Yes-- as of 2023, standalone batteries are included. The IRS now allows any new battery storage system of at least 3kWh to qualify for the 30% Residential Clean Energy Credit, even if it's not paired with solar panels. Is there an income limit for the solar battery tax credit? No. There's no income cap on claiming the credit.
